INFORMATION ON THE TREATMENT OF PERSONAL DATA MADE FROM MEDITERRANEAN FOUNDATION G.B. MORGAGNI UNDER THE TERMS OF ART. 13 OF LEGISLATIVE DECREE 196/2003 CONCERNING THE PRIVACY OF PERSONAL DATA.

The MEDITERRANEAN FOUNDATION G.B. MORGAGNI informs you that Legislative Decree n. 196 of 30 June 2003 ("Code concerning the protection of personal data") establishes a set of rules to ensure the protection of personal data.

The Foundation, in application of that order, will treat all personal data provided by you at the time of registration only for the purpose of managing the relationship established with you in all its aspects (training, accounting, etc.).

Data will be processed using manual and computerized procedures and also, in the ways and within the limits necessary for the above mentioned purposes.

The conferment of data is necessary for the management of the relationship and their absence will make it impossible to fully meet legal obligations.

According to Article 13 of the decree cited The Foundation is required to provide the following information:

The data provided will be treated by employees or collaborators of the Foundation). Data will be released:

- Only upon specific request, to the court.
